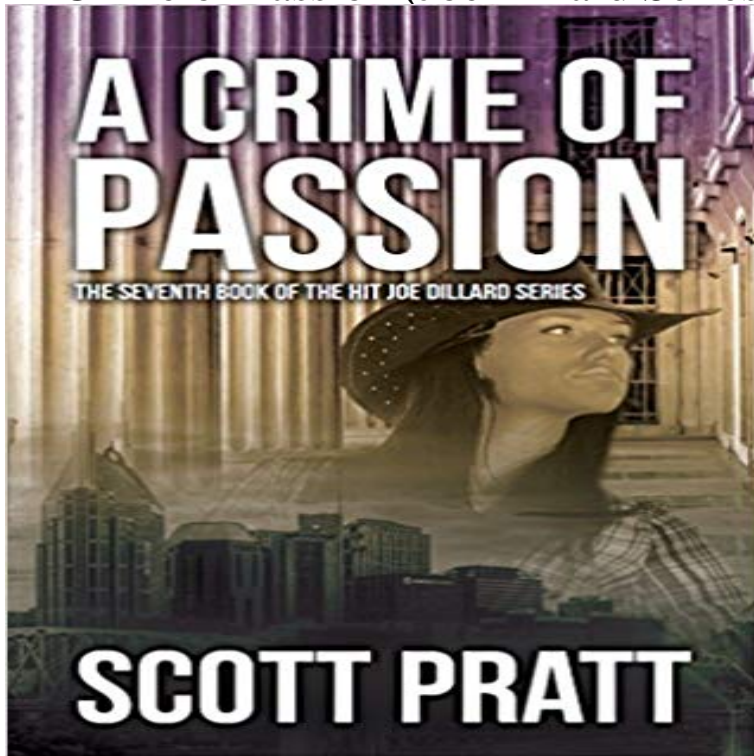


A Crime of Passion (Joe Dillard Series Book 7)
