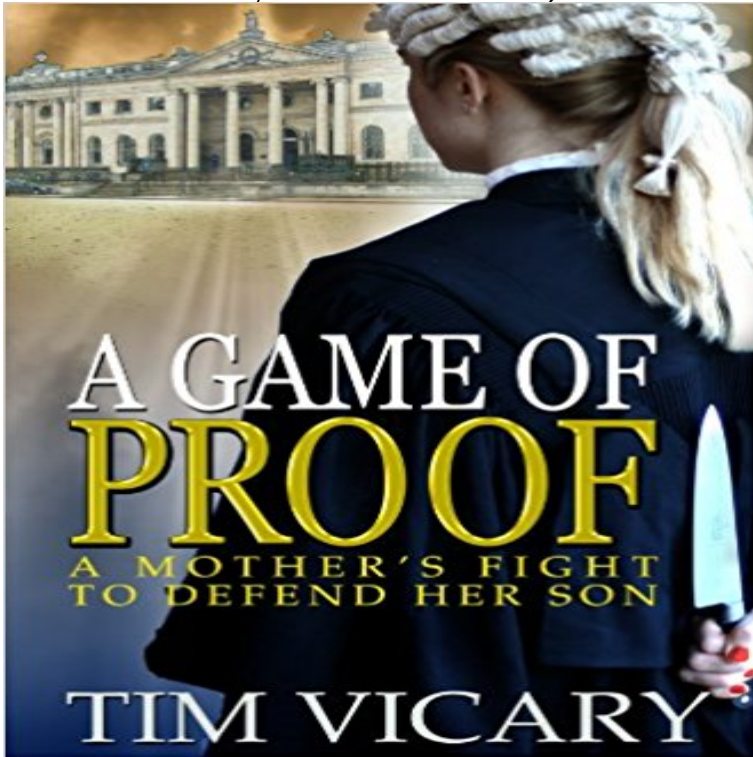


A Game of Proof: A Mothers Fight to Defend her Son (The Trials of Sarah Newby series Book 1)
