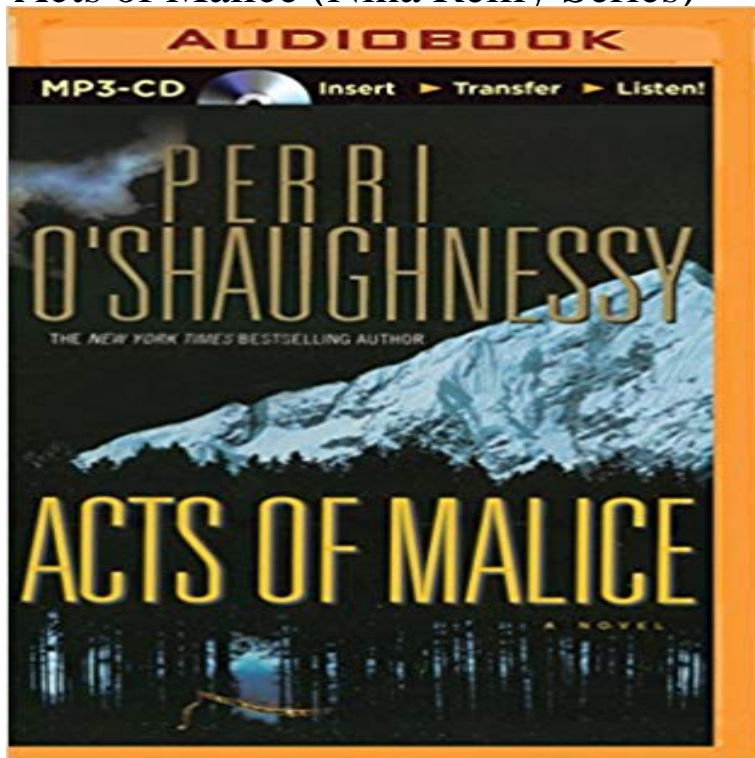


Acts of Malice (Nina Reilly Series)
