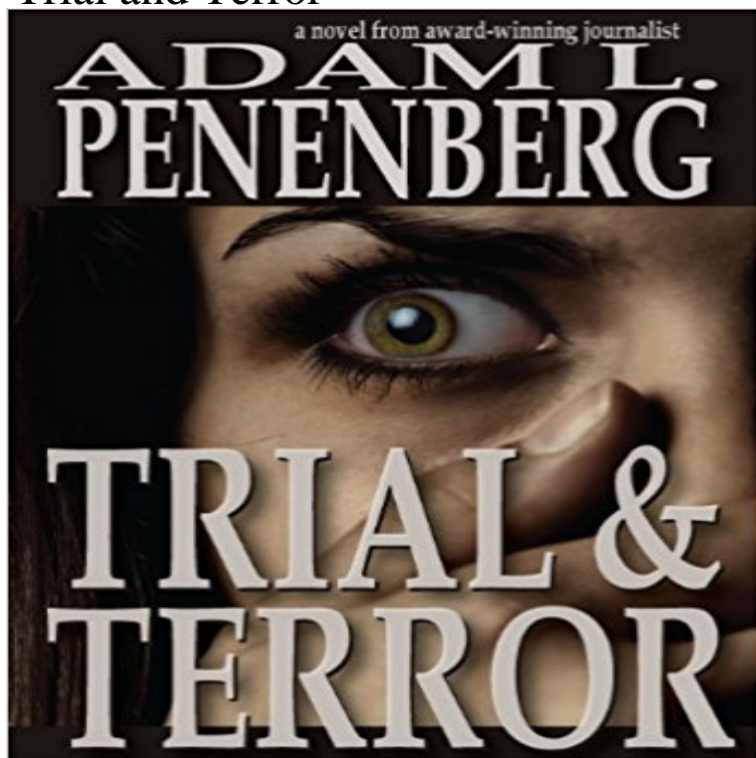


## Trial and Terror
