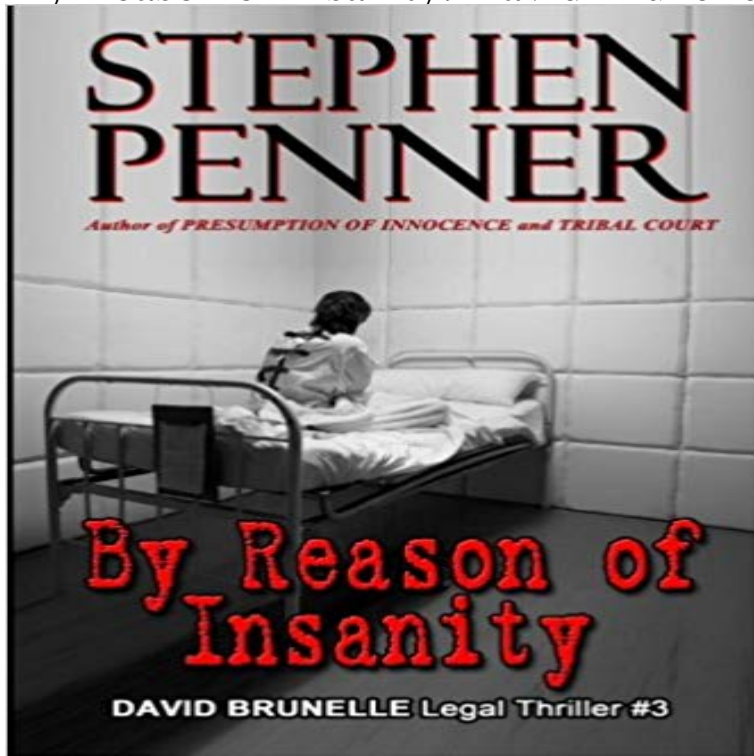


## By Reason of Insanity: David Brunelle Legal Thriller #3
