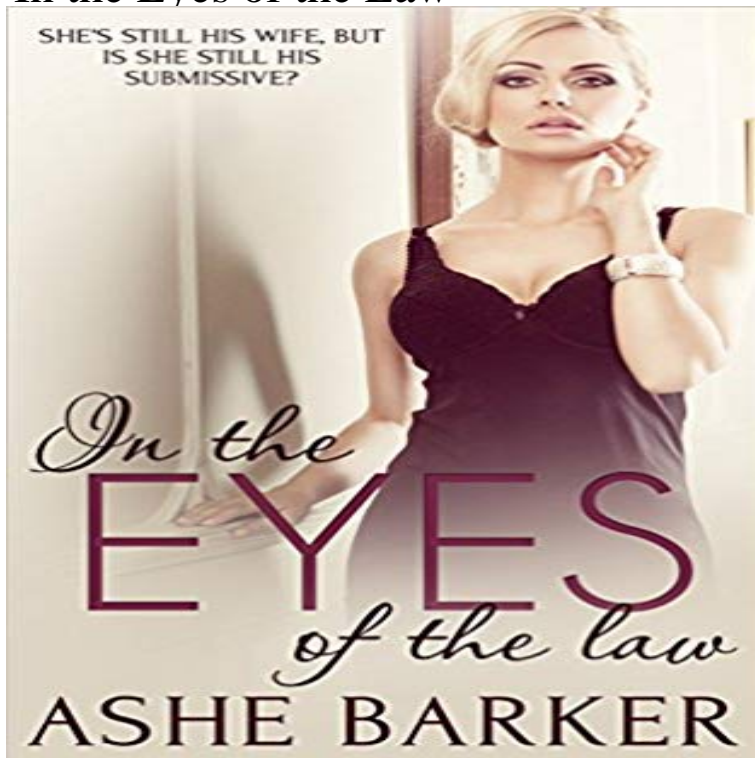


In the Eyes of the Law
