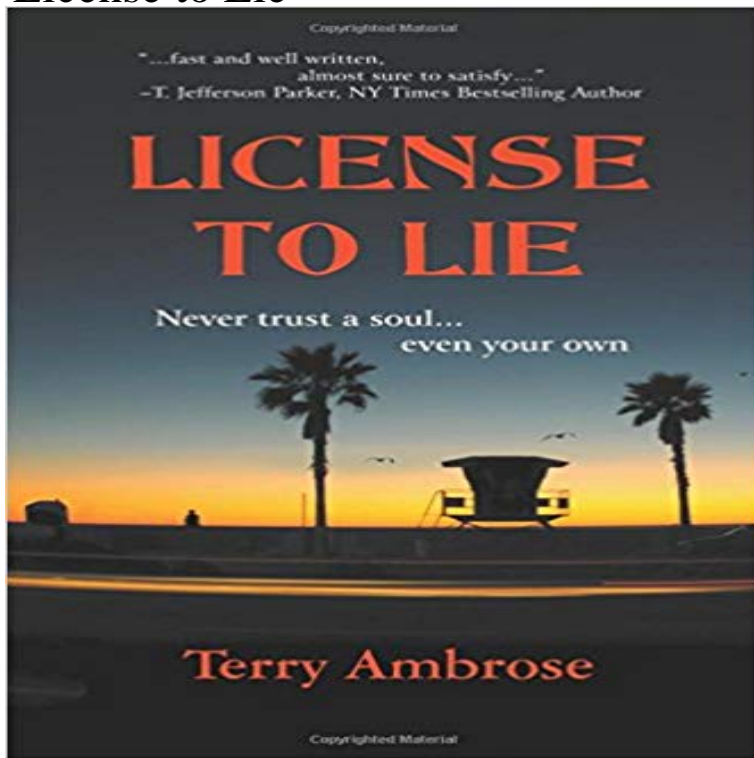


## License to Lie
