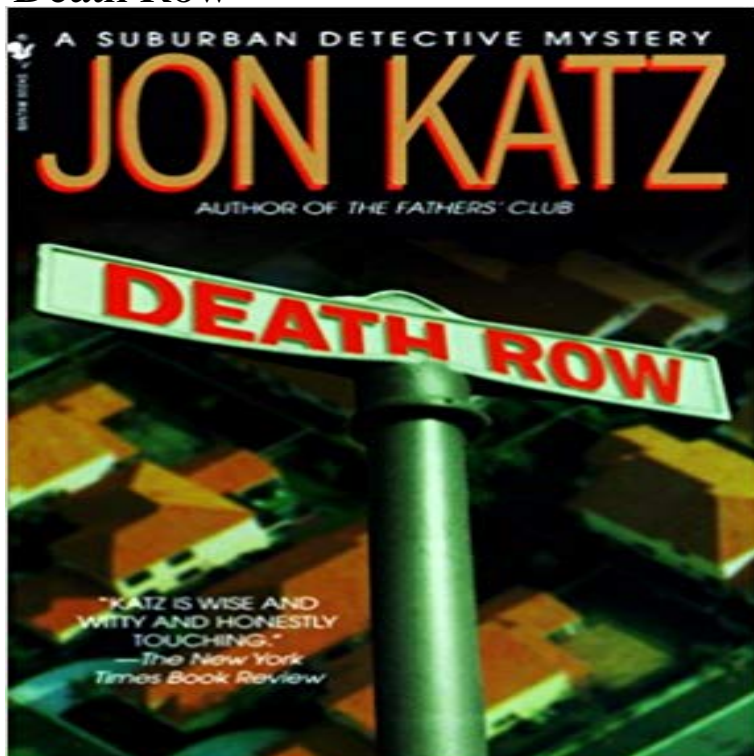


## Death Row
